Exciting Programs Scheduled

March 28, 2023 – "Pittsburgh's Old Stone Tavern" with Norene Beatty.

The history of Pittsburgh's oldest commercial building, the Old Stone Tavern, will be presented by Norene Beatty. The building initially operated as a tavern and inn. It served travelers and was a tavern where the Whiskey Rebellion conspirators once hatched their plans.

April 18, 2023 – "The Mt. Washington Transit Tunnel Disaster" with Mary Jane Hirt.

One of Pittsburgh's worst transit disasters happened on Christmas Eve in 1917. Ms. Hirt will tell of the disaster and the aftermath.

May 16, 2023 – "Unsolved Murder in Snowden Village" with Karen Lehr.

The 1928 unsolved murder mystery in the village of Snowden, a section of South Park, is explored by Karen Lehr. The murder of a coal miner's wife has never been solved. Ms. Lehr's extensive research includes photographs, the coroner's report, and statements from neighbors to answer the motive and other questions regarding the mystery.

June 20, 2023 – "Discovering a Family History: From the Famous and Heroic to the Infamous and Notorious" with Carleton Young.

Researching his family history, Mr. Young discovered he was related to many famous people in American history. He also found that along with the famous and heroic, there were family connections to a few infamous rogues and murderers as well.

Handel House Mystery

Leonard Marraccini presented the much-anticipated program on the history of the Handel House History



at the Society's November 2022 meeting. In his talk, Len gave a detailed early history of the house that dated back to the original Kiddoo family and concluded with the most recent owners. The house

once served as a stop for early settlers traveling from Brownsville to Pittsburgh, later a home and office for the justice of the peace, Herman Handel, his son, George, and later grandson, Cliff Handel. It also served as a polling place.

In recent years, the house was rumored to be haunted. Len and the Hauntings Research paranormal team investigated the home for any activity. Their results were very interesting.

The research and photos collected by Len enhanced his presentation, which was appreciated by the members and guests, who thoroughly enjoyed his outstanding presentation.

The Pittsburgh Press November 9, 1956

Snowden Hunts "City Hall" Site

"Snowden Township will have to start looking for a new site for its proposed municipal building. The township has asked for a tract of land in Sleepy Hollow Road, South Park, but Allegheny County commissioners, acting on the recommendation of Parks Director George B. McDonough, today turned down the request."

"Director McDonough told the commissioners that the Sleepy Hollow Road area is one of the most beautiful in the park and is slated for development into recreation and picnic spots."

Snowden Golf Course Tax Spiked

"Snowden Township's drive for an amusement tax at South Park's two golf courses landed in the rough today."

"County Solicitor Nathaniel K. Beck ruled that under a State Supreme Court decision, such a levy would be illegal. He explained that since the courses - one 18 holes and the other nine - are maintained by the County, the township where the park is located couldn't impose the tax."

"The high court has ruled, he said, that it is illegal for one taxing body to require another to collect taxes for the agency imposing the tax. Snowden sought the tax for revenue to hire a five-man police force."

"Snowden Township's surplus food distribution is scheduled for the Fulton & Powell Market, in Library, and the Kirschman Market, in Broughton, from 4 to 9 p.m. tomorrow."

Traffic Light Sought For Death Corner

Coroner Demands Action at Site Of Bethel Park Crash

"Coroner Joseph B. Dobbs asked yesterday for traffic lights and curbs at a five-way intersection in Bethel Park where a State Highways Department workman was killed."

"The request was made at an inquest into the death of Nicholas Rech, 65, of 3836 Grant Street, Library, on May 17."

Route 88 Crash

"Rech was killed when an auto, struck in the rear by another, went off Route 88 into the Verscharen's Market parking place."

"Drivers involved in the crash which injured three other men were cleared. They are Joseph M. Betz, 29, of 123 Fitler Street, Mt. Oliver, and William A. Buresch, Jr., 20, of 6524 Brownsville Road, Snowden Township."

"Betz said his car was struck from behind."

Dangerous Intersection

"The intersection, at the entrance to South Park on Route 88, has been the subject of controversy between state and borough officials. Division of costs is the issue."

"The intersection brings together Route 88, Corrigan Drive, Baptist Road, Library Road and South Park Road"

"Dobbs advocated action before county fair time in August when the intersection is heavily traveled. "If lights had been erected, Mr. Rech might be alive today," he added."
