that help establish an ancestral family tree. A lively question and answer session followed the Informative program.




and trusts, powers of attorney, probate, and executor responsibilities. A lively question-and-answer session followed the program.

ARCHIVED HISTORY

Pittsburgh Press June 21, 1886

Handel's Little Caucus

"Squire Handel, of Snowden Township has been figuring as a peacemaker. The township was divided on the 7th of this month, the new township of Bethel being formed out of a portion of it. The Bethelites had a red hot election for township officers on Thursday last, and half of the farmers in the district are not on speaking terms as a result."

"The vacancies created by the division in the old township offices were filled, subject to the approval of the court, by a quiet though largely attended caucus at Squire Handel's residence on Saturday night. David Riggs was named for tax collector, Ed Riggs and Robert McElheny for election inspectors, William Robinson for assessor, J. R. Phillips for assistant assessor, B. Berry for constable, J. C. Trax for auditor, and Jacob Lenhart for township clerk. The new School Board organized with Herman Handel as president, James Stewart secretary, and M. Nolan treasurer."

Pittsburgh Sun-Telegraph September 12, 1941

Snead Cards Par 72 At South Park Course

"Sammy Snead, who appears in a British War Relief Fund exhibition match at the Pittsburgh Field Club tomorrow afternoon with Gene Sarazen, Patty Berg and Helen Dettweiler, is in town for a few practice rounds."

"Snead, who injured his right hand while competing in the Tam O'Shanter tournament in Chicago last Sunday, played the South Park course yesterday and carded a par 72."

Pittsburgh Press May 27, 1934

Coal Tipple Burns

"Four volunteer fire companies fought a blaze at the tipple of Montour Mine No. 10 of the Pittsburgh Coal Company on Piney Fork Road, Snowden Township, last night. The fire was caused by a short in the electric wiring."

(Note: Piney Fork Road mentioned in the article is currently Brownsville Road. The Montour No. 10 mine is now the Summit Station development.)

Pittsburgh Press December 23, 1927

Doctor's Office Wrecked By Bomb

"The offices and reception room of Dr. D. M. Davis, a physician who has practiced among the miners of Curry and Horning for the last 27 years, were wrecked by a bomb placed just inside the door of the reception room of a two-story frame house at the Curry crossroads, early today."

"Dr. H. S. Lake, Dr. Davis' assistant, was asleep in his apartment on the second floor of the building and was tossed out of bed by the force of the explosion, but escaped injury. Every window in the home was shattered and furniture in the reception room and office was demolished. A large hole was blown in the floor of the reception room. State police today were working on possible clues to the bombers."

"Dr. Davis, since the strike of the union miners began nine months ago, has been practicing among the union men and their families gratis, and has been attending the sick among the non-union miners employed by the Pittsburgh Terminal Coal Corporation, for which, he is paid. Previous to the strike Dr. Davis was physician for both the union and the Pittsburgh Terminal Coal Corporation."

(Note: The doctor's office was located at the bottom of Broughton Road, near the intersection of Broughton and Curry Roads. Before it was razed, it housed an antique store. Dr. Davis moved his office from this location to a large house on Brownsville Road, across from Galley Funeral Home (currently Griffith Funeral Home.)

Pittsburgh Post Gazette July 1, 1931

Yard Caves In Under Woman

"Mrs. Anne Hadalin, of Library, was recovering yesterday from the shock of falling 20 feet into a mine entry room of Montour Mine No. 10 of the Pittsburgh Coal Co. when the earth in the yard of her home gave way."

"Mrs. Hadalin, the wife of a striking miner, was raking her garden when the ground collapsed and caused her to fall into the darkened entry, where she was imprisoned for nearly an hour before her cries attracted the attention of John Humes, fire boss at the mine."
